

## 1. Introduction

- 1.1. Onlyplay Giveaway (the "Giveaway") is organized by Onlyplay .
- 1.2. Slotsjudge solely provides game expert opinions and reviews for the Onlyplay Games.
- 1.2. Participation in the Giveaway constitutes full and unconditional agreement to and acceptance of these Terms and Conditions, as well as compliance with any applicable United Kingdom gambling laws and regulations.
- 1.3. The primary purpose of the Giveaway is to encourage engagement and gather player feedback on Onlyplay games.

- 3.1.2. Write an original review of the game, detailing both its pros and cons, indicating your Slotsjudge club nickname.
- 3.1.3. Submit the review by 31/08/2024, by posting a comment under game review (<https://slotsjudge.com/online-slots/piggy-tap/>).
- 3.2. Only one review per participant is allowed.
- 3.3. Review must be written by the participant, and must not be generated by AI tools. AI-generated content will result in immediate disqualification.
- 3.4. Review must include a screenshot of the Participants experience in the game. Screenshots can be taken from any casino website where this game is available, whether in demo mode or for real money, based on the Participant's preference.

## 4. Prizes

- 4.1. The prizes for the Giveaway are:
  - 4.1.1. First Prize: €500 Amazon Gift card.
  - 4.1.2. Second Prize: Onlyplay Merchandise.

- 6.4. Winners will be confirmed and notified via email within 10 days after the submission deadline.
